**\*\*\*A. INTRODUCTION\*\*\***

**1. Definitions:** All capitalized terms used in these Official Rules shall have the meaning ascribed to them in Section C entitled "Definitions" at the end of these Official Rules.

**2. Eligibility:** Only United States residents who are 18 years of age or older, and the age of majority in their states of residence if the age of majority is greater than 18, as of the first day of the Entry Period are eligible to participate in the Giveaway.
